## Fee-Based Course Rates and Discounts, 2025

This document delineates the courses offered, their course fees and applicable discounts. A participant is only eligible for one discount per course; discounts may not be combined.

The course fee includes unlimited access to online course materials and participation in live sessions with course faculty (for hybrid courses), participation in the in-person session, lunch and coffee/tea breaks during the in-person session and transport from the course venue to the clinics during field visits.

The fee does not include return travel from the participant's home country to the country where the inperson session will take place, travel insurance, visa costs or accommodation. The fee is payable via credit card or international bank transfer.

# **Union Employee Discount**

Union employees can attend fee-based courses at a discounted rate that will cover the variable costs. For hybrid courses, employees can attend the online session for free but they will need to cover the cost of the in-person course.

Participants with those conditions are limited to 5 per course. To sign-up, the employee supervisor must send a request to <u>unioncourses@theunion.org</u>

Places are available on a first-come first serve basis with a preference to employees that have not yet attended a course.

## **Early-Bird Discount**



Participants may take advantage of the early-bird discount of 5% by registering **and paying** for the course three months prior to the course. The early bird discount applies to all fee-based courses offered by The Union.

## **Group Discounts**

Organizations sending more than 5 participants to a single fee-based course will be eligible for a 5% discount when registering for the course.

# **Union Member Rate**

Union members will receive a discount on the fee-based courses. They must be active members, and their membership fees must have been paid for 2025 before registering for the course.

1. **Heritage member:** 10% Discount – up to 5 discounts per year per organisation

#### 2. Organisation member

- From low- and middle-income countries (LIC / LMIC): 10% Discount up to 2 discounts per year per organisation
- From upper middle-income countries (UMIC): 10% Discount up to 3 discounts per year per organisation
- High-income countries (HIC): 10% Discount up to 5 discounts per year per organisation

#### 3. Individual members: 5% Discount

Upon completing an international course with The Union, participants are automatically granted a one-year free Union membership (value 25 EUR for participants from LMICs or 250 EUR from participants from HICs). This benefit applies only to individuals who are not already members of The Union.
